Health promotion by preventing and curing diseases of various organs, using evolved homeopathy

ABSTRACT

When a close track is maintained on the health condition of all organs and endocrine systems of any person, no organ degeneration can take place; hence, organ transplant becomes avoidable; and, hence COVID virus doesn't get a 'soft' target in such human bodies. Thus, the requirement of achieving near zero disease-levels of various organs and endocrine systems, has become an important necessity in the COVID era. The methodology of evolved-homeopathy utilizes several specific medicines for prevention of various diseases, according to the first fundamental-principle of cure ("Prevention is better than cure"). True "nipping in the bud" of any disease from a patient's body is possible only when the treatment starts based not on a patient's perception of symptom(s) but on a whole-body diagnostic chart generated by a sophisticated device like the GDV (Gas discharge visualization) scanner. It is noteworthy to mention that evolved-homeopathy chooses organ-specific, constitutional and polycrest medicines, from various sources. Based on the experience of the persons who are utilizing the side-effect free preventive and curative medicines of evolved-homeopathy for preventing problems of various organs to achieve near zero disease-level, it is clear that the methodology of evolved-homeopathy for health promotion is very effective. It seems evident that for the sincere followers of the three fundamental-principles of cure as mentioned below, health promotion methodology of evolved-homeopathy is very beneficial. When the condition of near zero disease-levels in the various organs and endocrine systems of a person's body, is achieved, his/her Physical and mental stamina improves.

INTRODUCTION

Health promotion methodology of evolved homeopathy is very useful for any person to achieve near zero disease-levels in the various organs and endocrine systems of his/her body, as can be occasionally checked by using the GDV whole-body diagnostic system.

As mentioned in a previously published paper, three fundamental-principles of cure are the basis of evolved homeopathy¹: (i) Prevention is better than cure, and (ii) Nipping in the bud, and (iii) Identifying the exciting or Primary cause for acute diseases (Note-Samuel Hahnemann, organon of medicine, aphorism 5), for achieving quick cure and future prevention.

In another previously published paper, it has been described how the methodology of evolved homeopathy can be used by any person to maintain his/her heart, coronary vessels and cardiovascular system at near zero disease-level.² By following the three fundamental-principles of cure mentioned above, it is possible to prevent and even cure angina in the very initial stages (following "Nipping in the bud" principle); and, by then whatever little dead tissue forms in the myocardia and its nearby muscles, that can be eliminated subsequently by using one evolved homeopathy medicine. Thereafter, to avoid recurrence of any further angina attack, preventive medicines need to be taken to eliminate effect of the primary or the exciting cause.²

This paper presents ways: (i) to prevent and cure problems of various organs using evolved homeopathy medicines, and (ii) to achieve this by utilizing a sophisticated wholebody diagnostic device like the GDV scanner, details of which will be clear from the discussions in a previously published paper.¹

GDV WHOLE-BODY DIAGNOSTIC SYSTEM

In a previously published paper, detailed explanations had been given about a whole-body diagnostic chart generated by a sophisticated device like the GDV scanner.¹ According to that, true "nipping in the bud" of any disease is possible only when the treatment starts based not on a patient's perception of symptom(s) but on a whole-body diagnostic chart generated by this GDV device. For example, disease-levels due to problems in liver, stomach, and lungs, heart, etc. are indicated in the GDV diagnostic report.

Health promotion of various organs of any person can only be achieved when near zero disease-levels in the various organs of that person's body, is depicted by his GDV whole-body diagnostic chart.

EVOLVED-HOMEOPATHY AND COVID-19 ERA

As explained in a previously published paper, the need for evolved homeopathy (which is an evolved version of "advanced-homeopathy", developed by Dr. P. Banerji et al of Prasanta Banerji homeopathic research foundation (PBHRF), Calcutta) has arisen during the COVID era. ¹ The reason behind is that it has been observed that many diseases are stress-related disorders, and this is true for more diseases and for larger section of patients (including even children and teenagers) during the COVID era.

Potencies lower than those specified in advanced-homeopathy (which can be called 'specific homeopathy'), are sometimes more useful to avoid medicinal aggravation due to the action of the basic homeopathic principle: "similia similibus curentur".

Health promotion methodology of evolved homeopathy is very useful for any person to maintain his heart, coronary vessels, cardiovascular system, liver, stomach, and lungs, etc. at near zero disease-level, based on the occasional checking using the GDV whole-body diagnostic system.

PREVENTION IS BETTER THAN CURE

In addition to the four medicines mentioned in our previously published paper, two more medicines may be taken daily (once for persons having normal lifestyles, and twice for persons having tension-ridden lifestyles) for prevention of problems of heart, liver, stomach, and lungs, etc.²: (i) Cactus Gr. 2x; (ii) Crataegus oxy. 2x (a heart tonic); (iii) Cocculus ind. 2x; (iv) Colocynthis 2x; and (v) *Chelidonium majus* 2x; (vi) Ipecacuanha 2x.

It is important to mention that doses of these medicines should always be taken, keeping 20 minutes gap (from any consumption of food or drinks), before and after the medicine doses.

If any medicine is found to lead to aggravation even at 2x potency (due to the action of the principle of "similia similibus"), then 1x potency, should be used; in case, even 1x potency leads to aggravation, then mother-tincture (Q) itself (1 drop liquid, without diluting with water), should be used.

As mentioned in more detail with references, in our previously published paper, the following are being mentioned briefly here.²

Cactus grandiflorus is a medicine for the following important heart-related symptoms: aneurysm, angina, anxiety, constricting pain, dilatation, fatty degeneration, gouty heart, etc.^{3-13,18-21}

Crataegus oxyacantha is a medicine for the following important heart-related symptoms (a heart tonic according to Dr. Boericke): Angina, dilatation, fatty degeneration, and complaints of the heart, etc. ^{6-13,18-21}

Cocculus indicus is a medicine for the following important heart-related symptoms: anxiety, constricting pain, inflammation, palpitation, and complaints of the heart, etc. 3,7,9,13

Colocynthis is a medicine for the following important heart-related symptoms: palpitation, irritability, and complaints of the heart, etc. 3,6,7

Chelidonium majus is a medicine for following important liver symptoms: liver atrophy, pain, inflammation, distension, enlargment, swelling, fatty degeneration, fullness, hardness, stitching pain, soreness, etc.^{3,6,7,11}

Ipecacuanha, a very useful medicine for gastro-pneumonic nervous system, takes care of following important liver, stomach and lungs symptoms: stitching pain in liver, complaints of liver, inflammation in lungs, nausea, complaints of stomach, chill from disordered stomach, etc.^{3,7}

NIPPING IN THE BUD

The regular dosage of the few medicines mentioned in the previous section will prevent ailments of liver, stomach, lungs and heart, of most of the people, except for those few who are having excessive tension-ridden lifestyles. When we are attempting to achieve near zero disease-level for example, in liver of any patient, we are using one or more appropriate remedies additionally, if required, from the following: card-m., nat-s., ars., phos.; if these fail then we are using (sometimes reportorially) the following constitutional and polycrest remedies: merc, nit-ac., sulph.; and, nux-v., calc., chin., lyc.

IDENTIFYING THE PRIMARY OR EXCITING CAUSE OF A DISEASE, AND ELIMINATING IT

In a previously published paper, for quickly curing angina in bud stage, in description of case history 2, quick identification of the primary or exciting cause of angina, helped to select the right remedy, leading to the mildest case of occurrence of angina, its quickest cure and quick elimination of infarction.² Thus, quick identification of the primary or exciting cause of any other disease, also can help to select the right remedy, leading to its quickest cure.

RESULTS

Based on the experience of the persons who are utilizing the side-effect free preventive medicines of evolved homeopathy for preventing problems of various organs to achieve near zero disease-levels, it is clear that the methodology of evolved homeopathy for health promotion is very effective. However, this can be quite tedious, costly and time consuming, sometimes in case of some particular organ. Hence, we are continuously striving to improve health promotion methodology of evolved homeopathy.

Case history 1




Figure 1: Diagnostic chart of RV, a typical allopathy patient, who usually reports to the doctor after perception of a symptom.




Figure 2: Diagnostic chart of RV, after undergoing health-promotion.

In a previously published paper, the first case history referred to a COVID patient, who agreed to continue with evolved homeopathy medicines for health promotion. His organ conditions as depicted at Figure 2, as compared to the organ conditions as depicted at the previous Figure 1, reveals the improved degree of Health-promotion achieved by evolved homeopathy. When such a close track is maintained on the health condition of each of the organs and the endocrine systems of any person, no organ degeneration can take place, and hence organ transplant becomes unnecessary, and COVID virus doesn't get a 'soft' target in such human bodies. Thus, the requirement of zero disease-levels of various organs and endocrine systems, is important in the COVID era.

Case history 2

RV, a senior bureaucrat, had undergone health promotion. The organ conditions before and after health promotion are depicted respectively at Figure 1 and 2.

Unlike other cases of health-promotion, as presented in our previous two papers, here near zero disease level could not be reached in Figure 2 for all the organs. This was because this allopathy patient had too strong attachment to the allopathy medicines for diabetes-mellitus and hypertension (that are being continued for many years), and hence wanted to continue with them and did not like to stop them even for a short period.

DISCUSSION

It is noteworthy to mention that health-promotion can be achieved by evolved homeopathy, only for those persons, who are health-conscious and want to continue sincerely with the preventive medicines of evolved homeopathy and occasional GDV check-up, as may be necessary.

It may be mentioned that we are choosing organ-specific, constitutional and polycrest medicines, from 'Banerji protocols' and various other sources, based on the recent diagnostic report as occasionally checked by the GDV whole-body diagnostic system. ^{22,23}

However, it is quite tedious, and at times costly and time consuming to bring down the disease level of some particular organ. So, for such cases we are either not able to reach near zero disease-level, or with the patient's consent need to use what can be called an "individualistic homeopathic medicine" that can be generated by the GDV device, by feeding an electromagnetic signal from the device to a medicine preparation device. This technique/method we learnt from other GDV users more than 15 years ago; and, since then we, both the authors and our close associates are successfully using this electromagnetic signal-generated homeopathic medicine for curing our ailments of various organs.

CONCLUSION

Health promotion methodology of evolved homeopathy is very beneficial for any person. When the condition of near zero disease-levels in all the organs of human body, is achieved, about 20 years age-reduction is felt, and physical as well as mental stamina improves. However, sometimes this can be quite tedious, costly and time consuming, in case of some particular organ. So, we are working continuously to improve the methodology, to make it less time consuming.
