Good and rapid health promotion by curing diseases of various organs, using digital homeopathy

ABSTRACT

Health promotion methodology of evolved homeopathy is very useful to achieve near zero disease-levels in the various organs of a person's body, only for those persons, who are health-conscious and want to continue sincerely with the preventive medicines of evolved homeopathy and digital homeopathy, and occasional GDV (Gas discharge visualization) check-up, as may be necessary. The methodology of evolved homeopathy utilizes medicines of digital homeopathy and evolved homeopathy for prevention and cure, according to the first fundamental-principle of cure ("Prevention is better than cure"). True "nipping in the bud" of any disease from a patient's body is possible only when the treatment starts based not on a patient's perception of symptom(s) but on a whole-body diagnostic chart generated by a sophisticated device like the GDV scanner. Based on the experience of the persons who are utilizing the side-effect free preventive and curative medicines of evolved-homeopathy and digital homeopathy for preventing and curing problems of various organs to achieve near zero disease-level, it is clear that the methodology of evolved-homeopathy and digital homeopathy for health promotion, is very effective. It seems evident that for the sincere followers of the three fundamental-principles of cure as detailed below, health promotion methodology of evolved homeopathy and digital homeopathy, is very beneficial. When the condition of near zero disease-levels in the various organs of a person's body, is achieved, about 20 years age-reduction is felt along with improvement of physical and mental stamina.

INTRODUCTION

Health promotion methodology of evolved homeopathy is very useful to achieve near zero disease-levels in the various organs of a person's body, but only for those persons, who are health-conscious and want to continue sincerely with the preventive medicines of evolved homeopathy (and of digital homeopathy, when required) and occasional GDV check-up, as may be necessary.

As mentioned in a previously published paper, evolved homeopathy is based on three fundamental-principles of cure: (i) nipping in the bud, (ii) prevention is better than cure, and (iii) identification of the primary or exciting cause for acute diseases (note-aphorism 5, organon of medicine, Samuel Hahnemann), for achieving quick cure and future prevention.¹

In another previously published paper, it has been described how the preventive methodology of evolved homeopathy can be used by any person to maintain his/her heart, cardiovascular system and coronary vessels at near zero disease-levels.² By following the three fundamental-principles of cure mentioned above, it is possible to prevent and even cure angina in the very initial stages; and, by then whatever little dead tissue forms in the myocardia and its nearby muscles, those can be eliminated by using one evolved homeopathy medicine as and when required. Also, to avoid recurrence of further angina attack, preventive medicines need to be taken as and when

required, to eliminate the effect of the exciting or the primary cause.

This paper presents ways to prevent and cure problems of various organs using evolved homeopathy medicines and digital homeopathy medicine (note- digital homeopathy medicine is used for those persons who opt for it); and, achieve this by utilizing a sophisticated whole-body diagnostic device like the GDV scanner, details of which are given in a previously published paper.¹

GDV WHOLE-BODY DIAGNOSTIC SYSTEM

True "nipping in the bud" of any disease from a patient's body is possible only when the treatment starts based not on a patient's perception of symptom(s) but on a whole-body diagnostic chart generated by a sophisticated device like the GDV scanner, as will be clear from the detailed explanations given in a previously published paper. For example, disease-levels due to problems in liver, stomach, and lungs, etc. are indicated in the GDV diagnostic report.

The GDV device is being used as an important tool for achieving near zero disease-levels in the various organs of human body, that leads to Health promotion.

EVOLVED-HOMEOPATHY AND COVID-19 ERA

The need for evolved homeopathy (which is an evolved version of "advanced-homeopathy", as explained in a previously published paper) has arisen during the COVID era, as it has been observed that many diseases are stress-related disorders, and this is true for more diseases and for larger section of patients (including even children and teenagers).¹

It has been found that potencies lower than those specified in advanced-homeopathy (which can be called 'Specific homeopathy'), are sometimes more useful to avoid medicinal aggravation based on the basic homeopathic principle: "similia similibus curentur".

Health promotion methodology of evolved homeopathy is very useful for any person to maintain a person's heart, coronary vessels, cardiovascular system, liver, stomach, and lungs, etc. at near zero disease-levels, based on the occasional checking using the GDV whole-body diagnostic system.

PREVENTION IS BETTER THAN CURE

The following six medicines may be taken daily (once for persons having normal lifestyles, and twice for persons having tension-ridden lifestyles) for prevention of liver, stomach, lungs and heart problems, etc., as mentioned with References in our previously published papers.^{2,3}

(i) Cactus Gr. 2x; (ii) Crataegus Oxy. 2x (a heart tonic); (iii) Cocculus Ind. 2x; (iv) Colocynthis 2x; and (v) Chelidonium Majus 2x; (vi) Ipecacuanha 2x.

It is important to mention that doses of these medicines should always be taken, keeping 20 minutes gap (from any consumption of food or drinks), before and after the medicine doses.

If any medicine is found to lead to aggravation even at 2x potency (due to the action of the principle of "similia similibus"), then 1x potency, should be tried; in case, even 1x potency leads to aggravation, then mother-tincture (Q) itself, should be used.

NIPPING IN THE BUD

The regular dosage of the few medicines mentioned in the previous section (2.3) will prevent ailments of liver, stomach, lungs and heart, of most of the people, except for those few who are having excessive tension-ridden lifestyles. When we are attempting to achieve near zero disease-level for example, in liver of any patient, we are using one or more appropriate Remedies additionally, if required, from the following: Carduus-M., Natrum-S., arsenicum alb., phosphorus; if these fail then we are using (sometimes reportorially) the following constitutional and polycrest remedies: Mercurius Viv., Nitricum-Ac., sulphur; and, nux-vom, calcarea carb., China, lycopodium.

However, digital homeopathy works simultaneously for all the organs and quickly cures all organ problems that are close even to the bud stage.

IDENTIFYING THE PRIMARY OR EXCITING CAUSE OF A DISEASE, AND ELIMINATING IT

In a previously published paper, for quickly curing angina in bud stage, in description of case history 2, quick identification of the primary or exciting cause of angina, helped to select the right remedy, leading to the mildest case of occurrence of angina, its quickest cure and quick elimination of infarction.²

Thus, quick identification of the primary or exciting cause of any other disease, also can help to select the right remedy in evolved homeopathy, leading to its quickest cure.

OBSERVATIONS

Based on the experience of the persons who are utilizing the side-effect free preventive medicines of evolved homeopathy for preventing problems of various organs to achieve near zero disease-levels, it is clear that the methodology of evolved homeopathy for health promotion is very effective. However, this can be quite tedious, costly and time consuming, sometimes in case of some particular organ. We are continuously striving to improve health promotion methodology of evolved homeopathy. Thus, we found that the effect of digital homeopathy medicine is quicker and good in improving the conditions of various organs and endocrine systems simultaneously.

Case history 1




Figure 1: Diagnostic chart of LST, a typical allopathy patient, who reports to the allopath after perception of a symptom.




Figure 2: Diagnostic chart of LST, after he has undergone health-promotion using "digital homeopathy".

LST, a typical patient, who has very strong inclination for allopathy treatment, and usually reports to the Allopathy doctor after perception of a symptom, and continues with the medication till reported fit by the Allopath, was diagnosed using the GDV device, as he desired to undergo

health promotion; Figure 1 depicts his initial organ conditions. His treatment with the curative medicines of evolved homeopathy and digital homeopathy (as he opted for it) was done, and then he was diagnosed finally; Figure 2 depicts his final organ conditions.




Figure 3: Diagnostic chart of AB, who has undergone health-promotion regularly using "digital homeopathy", for one and a half decade.

Case history 2

This case history relates to Figure 3, which is the diagnostic chart of AB, who has undergone health-promotion using "digital homeopathy" for prevention and cure, for one and a half decade regularly.

DISCUSSION

It has been mentioned in a previously published paper, that health-promotion can be achieved by evolved homeopathy, only for those persons, who are healthconscious and want to continue sincerely with the preventive medicines of evolved homeopathy and occasional GDV check-up, as may be necessary; it has also been mentioned there that we are choosing organ-specific, constitutional and polycrest medicines, from 'Banerji protocols' and various other sources, based on the recent diagnostic report as occasionally checked by the GDV whole-body diagnostic system; it has been further mentioned there that it may be quite tedious, and at times costly and time consuming for bringing down the disease level of some particular organ; so, for such cases we are either not able to reach near zero disease-level, or with the patient's consent need to use what can be called an "individualistic homeopathic medicine" that can be generated by the GDV device, by feeding an electromagnetic signal from the GDV device to the digital homeopathy medicine preparation device.³⁻⁵

In response to a private communication, fifteen years ago, the inventor of GDV technique (invented in 1995), Prof. Konstantin Korotkov of St. Petersburg federal research university of ITMO (Informational technologies, mechanics and optics), stated based on his decade-long experience, that when a patient places an appropriate finger which relates to a problem of a particular organ, on the GDV scanner, and scanning of the finger tip is done, GDV signal can be used to create an individual homeopathy, for the ailment of that organ.

In a typical Hahnemannian style of proving a homeopathy medicine, we, both the authors and our close associates are successfully using this electromagnetic signal-generated Digital homeopathic medicine for curing our ailments of various organs, since we learnt this technique/ method from other GDV users more than 15 years ago (which proves that the digital homeopathy medicine is good for even long term use).

Digital homeopathy can be said to be meeting the best of requirements of any patient that Hahnemann wanted for meeting in his classical homeopathy; because, it takes care of all the symptoms of any particular patient (not only those perceptible to that particular patient, but also those which are below the perception level of the patient, as explained in a previously published paper). Digital homeopathy generates a medicine tailored to both types of symptoms, which is almost impossible according to even the best of classical homeopathy. In this connection, Dr. P.

Banerji et al, stated in 'Banerji protocols' in the preface (The background) of this book, that the subjective symptoms elicited in the typical two-hour initial consultation are often "lost in the translation", thus, should a patient be examined separately by different homeopaths on the same day, he will be perplexed to find that none of them seem to agree as to the so-called "similimum" at the end.⁴

Hahnemann stated in 'organon' that without the "instinctive, unconscious, and unreasoning, but automatic vital force", the material organism is incapable of feeling, activity, or self-preservation; and, that this immaterial being (vital force) alone, animating the organism in a state of sickness and health, imparts the faculty of feeling, and controls the functions of life". 6

Dr. Boericke stated that Hahnemann saw in the body but an organism made up of material particles in themselves dead, but vivified and embodied and adapted to the real, living man, the spirit within; the connection between the immaterial, spiritual and immortal being, and the body is supposed by him to be effected by means of the vital force which he designates as Dynamis; this Dynamis differs from the material body in being of a more subtle quality and Hahnemann defines it, in contradiction of the material grossness of the body, as "spirit-like"; the vital force is active throughout the body, and is the immediate cause of every functional activity, of all bodily growth; it is the formative force of the organism, is in fact the inner form, which controls the molecular, chemical and mechanical processes, and uses them for its own purposes. 7 In Hahnemann's words, the Dynamis is really a subtle energy body, that controls the molecular, chemical and mechanical processes, of the physical body; this subtle energy body has been well identified by (i) acupuncture system of healing methodology of the traditional Chinese medicine (TCM), whose practitioners believe the human body has more than 2,000 acupuncture points connected by pathways or meridians; these pathways create an energy flow (Qi, pronounced "chee") through the body that is responsible for overall health of any person; disruption of the energy flow can cause disease; by applying acupuncture to appropriate points, it is thought to improve the flow of Qi, thereby improving health; studies at the Johns Hopkins university, have shown that acupuncture is effective for a variety of conditions in human body.8 TCM maintains that the chi (life-force) flows through the body along channels called meridians, and that a blockage in one or more of these meridians cause ill health. Acupuncturists aim to restore health by inserting needles (which are stimulated by rotation or by an electric current) at appropriate points along the affected meridians.⁹ (ii) the GDV scanner/bio-well instrument, which utilizes the scanned finger-tip images of this subtle energy field, for analyzing (based on the energy flow at different segments of any particular finger-tip, according to the Acupuncture principle), and generating a sophisticated whole-body diagnostic chart, indicating the disease-level of every organ of the human body. Numerous publications by

scientists from different countries have shown that the analysis of energy field images allows for registering the radiation activity from the bio-field of any organism. Biowell imaging provides a convenient means for observing the dynamics of an individual's changing state during a person's life or under the influence of a therapy. The image created using the GDV scanner or the bio-well instrument is based on working ideas of TCM and verified by 20 years of Western clinical experience conducted by hundreds of medical doctors with many thousands of patients. Acupuncture

Acupuncture points are known to stimulate the central nervous system of the human body. This, in turn, releases neuro-transmitters into the brain, spinal cord, and muscles. These biochemical changes help to stimulate the body's natural healing abilities and promote emotional and physical well-being.⁷

During the Ming dynasty (1368-1644 AD), the "Great compendium of acupuncture and moxibustion" was published (in 1601); most of the acupuncture practices used till that era had been established in China; in this book clear descriptions of a set of 365 points that represent openings to the sites along the affected meridians through which needles could be inserted to modify the flow of Qi energy, are given.¹⁵

After the Jesuit missionaries brought back reports of acupuncture in the sixteenth century, the practice of acupuncture was embraced by French clinicians fairly widely. Berlioz ran clinical trials on acupuncture and wrote a text in 1816. Modern French acupuncture has been deeply influenced by a diplomat, Souliet du Morant, who spent many years in China and published a number of treatises about acupuncture from 1939 onwards.

In the medical literature in US, acupuncture was first mentioned in 1822; Sir William Osier endorsed the use of acupuncture for management of lumbago in his 1892 book 'the principles and practice of medicine'. ¹⁶ Dominic stated that it took ~300 years for Europe and ~400 years for the USA to finally appreciate the therapeutic value of acupuncture; findings from basic medical research revealed that acupuncture stimulation causes release of enkephalins, endorphins, serotonin, and γ -amino-butyric acid (GABA, an important inhibitory neurotransmitter of the brain), norepinephrine, and dopamine; this helped to explain the acupuncture effect on a biomedical and pharmacological basis that became acceptable to the Western medical establishment. ¹⁷

CONCLUSION

In view of the above, it is clear that more than two centuries ago, it required the genius of Hahnemann to intuitively understand the existence of subtle energy body that controls the molecular, chemical and mechanical

processes of the physical body of a human being. On the other hand, acupuncture was being practiced in France, China, Korea, Japan and USA, etc. during the nineteenth and twentieth centuries. But, it needed the development of the field of information technology during end of the twentieth century, which paved the way for the development of GDV whole-body diagnostic system, which generates the electromagnetic signals for all the perceptible and the imperceptible (Note-As explained in our previously published paper, symptom of any organ becomes perceptible, only when the GDV indicated organ condition reaches a value above 1.0.) organ conditions of any person, which can be used to generate a truly (because it is generated out of both the perceptible and the imperceptible type of symptoms of all the organs/systems of any person) "individualistic homeopathic medicine", and which can be called "digital homeopathy" and can be used for health promotion of that person. Another great contribution came from Russian electrical engineer Semyon Kirlian, who developed Kirlian photography technique that is one of the foundations for development of the GDV device. Health promotion methodology of evolved homeopathy is very beneficial for any person. When the condition of near zero disease-levels in various organs of human body, is achieved, about 20 years agereduction is felt, physical and mental stamina improves. However, sometimes this can be quite tedious, costly and time consuming, in case of some particular organ. So, we are working continuously to improve the methodology, to make it less time consuming. In view of the above, it is noteworthy to mention that health promotion using digital homeopathy leads to rapid health promotion, since all the organs can be cured simultaneously.
